2. Permanent increase in seats was granted to B.Com with Computer Application(40 to 60 intake), B.Sc Costume & Fashion Designing(24 to 36 intake), B.Sc Hotel Management & Catering Science(24 to 36 intake) with effect from the academic year 2014-15, vide University Order read as first above.

3. Additional affiliation was granted to Master of Business Economics (MBE-15 seats) during the academic year 2014-15 with permission to start classes in the academic year 2015-16, vide University Order read as second above. The programme has been changed as MA Business Economics (15) and also granted provisional affiliation to the programme MA Business Economics with effect from academic year 2022-23 onwards vide University Order read as eighth above.

4. Permanent increase in seats was granted to BBA(30 to 40 intake), BA English(24 to 40 intake), MCom(15 to 20 intake) and MSc Apparel Designing & Technology(10 to 12 intake) with effect from the academic year 2016-17, vide University Order read as third above.

5. Nomenclature of M.Sc Apparel Designing & Technology programme has been changed to M.Sc Fashion & Textile Designing with effect from 2014 admission onwards vide University Order read as fourth above.

6. Continuation of provisional affiliation was granted to the aforementioned programmes for the academic year 2021-22, vide University Order read as fifth above.

7. The Principal, Holy Cross Institute of Management and Technology, Kozhikode, vide paper read as sixth above, has applied for continuation of provisional affiliation to the existing programmes in the college for the academic year 2022-23 remitted fee towards affiliation of ₹2,65,000/- (Rupees Two Lakh and Sixty Five Thousand only) online vide chalan no. 212639945 dated 28.12.2021. Vide paper read as seventh above, Principal has submitted renewal of NOC from Govt. for the academic year 2022-23.

8. After considering the case in detail, the Vice Chancellor has accorded sanction, on 11.11.2022, for granting continuation of provisional affiliation to the aforementioned programmes at Holy Cross Institute of Management and Technology (Un-aided), Eranhipalam P.O, Kozhikode for the academic



year 2022-23 with strict directions to Principal to engage faculties with qualification prescribed by UGC and in compliance to the provisions of the ACT 13 of 2021 -Kerala self financing college teaching and non teaching employees (appointment and conditions of services).

9. Continuation of provisional affiliation is, therefore, granted to the following self financing programmes at Holy Cross Institute of Management and Technology (Un-aided), Eranhipalam P.O, Kozhikode for the academic year 2022-23 subject to the conditions mentioned thereunder:

10. The Principal shall strictly follow the syllabi approved available in the University website [www.uoc.ac.in](http://www.uoc.ac.in) for selecting complementary courses.

11. The complementary courses/common courses specified in this order are based on the details of registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject/for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University.

12. Selection and admission shall be made only on the basis of the rules and regulations of the University/ Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

13. In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

14. Affiliation granted is strictly provisional and only for the academic year 2022-23. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University.

15. The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid affiliation orders.

16. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

17. Admission to the next academic year shall be made only after obtaining prior permission from the University.

18. The college is liable to comply with the general conditions stipulated in the renewal of NOC for the academic year 2022-23, issued by Higher Higher Education Department, Govt of Kerala.

**19. The Principal is directed to strictly adhere to qualifications prescribed by UGC and in compliance to Provisions under Act 13 of 2021 Kerala self financing college teaching and non teaching employees (appointment and conditions of services) while engaging faculties.**

2. Extract of the minutes of meeting of the Syndicate held on 05.09.2022 vide Item no. 2022.1013\* (confirmed item No 2022.1086\* on 11.10.2022)

**ORDER**

As per UGC Regulations 2014, the nomenclature of Master of Business Economics (MBE) to be restructured as MA/MBA/M.Com (Business Economics). Principal of Holy Cross Institute of Management & Technology, Eranhipalam, Kozhikode has requested to consider changing the nomenclature of the programme Master of Business Economics (MBE) to MA Business Economics. Considering the request,the Board of Studies in Economics PG has examined the matter in detail and recommended to change the programme from Master of Business Economics (MBE) to MA Business Economics with effect from academic year 2022 onwards and the Dean, Faculty of Humanities has approved the same resolution. The Vice Chancellor has accorded sanction to implement the above recommendations. The Syndicate in its meeting held on 15.07.2022 has considered the matter and resolved vide item no. 2022.830\* to refer the matter to Standing Committee of Syndicate on Courses and Research for detailed study.

2. Subsequently, Standing Committee of Syndicate on Courses and Research has recommended the change of the programme from Master of Business Economics (MBE) being offered at Holy Cross Institute of Management & Technology, Eranhipalam, Kozhikode to MA Business Economics with effect from the academic year 2022- 23 onwards based on the instruction of UGC and the recommendations of the concerned Board of Studies and the Dean of Faculty of Humanities. Considering the matter, Vice Chancellor has accorded sanction to entrust District Level Inspection Committee, Kozhikode to verify facilities available for the conduct of MA Business Economics programme at the college, for considering the matter of granting provisional affiliation to the programme. District Level Inspection Committee, Kozhikode conducted inspection and submitted the inspection report recommending the change of programme and granting provisional affiliation to MA Business Economics.

3. Considering the exigency of the matter , Vice Chancellor as envisaged in Chapter III, 10(13) of Calicut University Act, 1975, has accorded sanction for changing of the programme from Master of Business Economics (MBE) to MA Business Economics (15) with effect from 2022-23 and granting of provisional affiliation to the self financing programme MA Business Economics (15) at Holy Cross Institute of Management & Technology, Eranhipalam, Kozhikode in the academic year 2022-23, subject to ratification by the Syndicate and Concurrence from Govt. of Kerala.

4. Accordingly, the programme has been changed from Master of Business Economics (MBE) to MA Business Economics (15) with effect from 2022-23 and granted provisional affiliation to the self financing programme MA Business Economics (15) at Holy Cross Institute of Management & Technology, Eranhipalam, Kozhikode for the academic year 2022-23 ,subject to ratification by the Syndicate and Concurrence from Govt. of Kerala vide University order read as first above.

5. The aforesaid action taken by the Vice Chancellor was ratified by the Syndicate in its meeting held on 05.09.2022 vide Item no. 2022.1013\* (confirmed item No 2022.1086\* on 11.10.2022), vide paper read as second above .

6. Vice Chancellor has accorded sanction on 21.10.2022 to implement above resolution of the Syndicate.
